

# National Technical Advisor- National Veterinary Services (OSRO/INS/103/USA) NPP 10

The National Technical Advisor shall operate under the overall guidance of the FAO Chief Veterinary Officer, the general technical supervision of the Emergency Centre for Transboundary Animal Diseases (ECTAD) Regional Manager based in the Regional Office for Asia and the Pacific (RAP) and the operational supervision of the Chief, Emergency Operations Service (TCEO).

The incumbent will be under the direct supervision of the Team Leader and Chief Technical Advisor (CTA) of the FAO HPAI Programme in Indonesia and the general operational and administrative guidance of the FAO Representative.

Specific responsibilities will include:

The National Technical Advisor (NVS) will undertake management of project implementation including:

- Support to Rapid Response Unit- Strategic Contagious Animal Diseases and the Directorate of Animal Health in the development and expansion of the National Veterinary Services including the scheduling of training.
- Establish contact and working arrangements with appropriate staff of the Ministry of Agriculture and other local government departments/divisions and organizations.
- Lead the development, design and testing of curriculum and training materials and delivery of training sessions to build capacity for local government, for the NVS and the Rabies Control projects.
- Provide technical support to NVS and rabies control project to control HPAI, brucellosis, anthrax, hog cholera, rabies, dog skin diseases, blood parasites in cattle and other diseases of importance to the local communities.
- Lead the design and implementation of a Master Trainer development programme; carry out TOTMTs and support MTS to take on training and mentoring roles.
- Carry out post training mentoring of field activities and hold meetings with the relevant Dinas to discuss findings
- Support data collection in collaboration with the monitoring and evaluation team
- Contribute to regular ECTAD and donor reports of the LG team
- Support annual planning activities, prepare and review activity narratives, targets and tracking formats.
- Perform other related duties as required

## Reporting

- Regular report of field activities including include monthly COP and activity tracking and support ECTAD reports on a quarterly or 6-monthly basis
- Prepare a final report containing a complete review of activities undertaken, major results obtained, problems encountered, recommendations and lessons learned. The report should be submitted to ECTAD no later than two weeks after completion of the assignment.

- Bachelor degree in Veterinary Science or a related subject
- Indonesian Nationality
- Minimum of 5 years experience in the management and surveillance of animals diseases including HPAI, rabies and, anthrax, brucellosis and hog cholera,
- High priority will be given to candidates with experience of working with animal health services within the Indonesian government.
- Knowledge of participatory training methods and approaches and experience in the development of training modules
- Knowledge of the FAO system and relevant experience in project management would be an advantage.
- Proficiency in both written and spoken in English is required
