The National Technical Advisor – Poultry Health Training shall operate under the overall guidance and responsibility of the FAO Chief Veterinary Officer, the general technical supervision of the Emergency Centre for Transboundary Animal Disease Operations (ECTAD) Regional Manager based in the Regional Office for Asia and the Pacific (RAP) in Bangkok and the operational supervision of the Chief, Emergency Operations Service (TCES). The incumbent will be under the general technical supervision of the Team Leader of the FAO ECTAD Country Programme in Indonesia and the Chief Technical Adviser (Implementation and System Development), the direct supervision of the Senior Technical Advisor (Local Government and Training), and the functional and administrative guidance of the FAO Representative in Indonesia.

#### Specific responsibilities will include:

- With the other PVUK NVS, support the development of PVUK strategy in consultation with URC and the STA
- Develop and review training material, methods, and curriculum for government staff and farmers to include biosecurity, disease control, management for all commercial poultry types.
- Assist in the design and implementation of the PVUK programme expansion
- Provide technical input for modules covering training skills, poultry diseases, vaccination, biosecurity, problem investigation and medicinal drug use
- · Deliver veterinary training for PVUK field officers
- Mentor PVUK trainees in collaboration with URC and the local government. in all aspects of PVUK work: group formation, farmer training
- Plan the training and mentoring schedules with URC
- Liaise with and the private sector to support PVUK activities and assist in development of private-sector focused training material based on PVUK training material
- Oversee design and implementation of a Master Trainer development programme; carry out TOTMTs and support MTS to take on a mentoring role.
- Reports include monthly COP and activity tracking and support ECTAD reports on a quarterly or 6-monthly basis
- Support annual planning activities, prepare and review activity narratives, targets and tracking formats.
- · Perform other related duties as requested

### **Expected Outputs:**

- Modules for training PVUK and farmers, updated when necessary.
- PVUK officers able to train and support farmer's groups in the field
- A network of MTs able to support and mentor PVUK trained staff in the field
- Scheduled training, CE training and TOTMTs carried out
- Strong linkages and improved trust between private sector and government
- PVUK promoted as a desirable intervention on poultry producing areas of Indonesia
